NOTICE OF PUBLIC HEARING APPLICATION FOR A CAPITAL IMPROVEMENT RENT INCREASE

The Carson Mobilehome Park Rental Review Board ("Board") will conduct a public hearing concerning a Capital Improvement Rent Increase Application filed by the owner of Colony Cove Mobile Estates. You and/or a collective representative of the park may participate and be heard at the date, time, and place of the meeting as follows:

- DATE:** Wednesday, October 14, 2020
- TIME:** 6:30 P.M.
- PLACE:** The hearing will be conducted remotely via electronic teleconferencing and broadcast live on television and on the City's website*.
- APPLICANT:** Colony Cove Properties, LLC

***DUE TO THE COVID-19 PANDEMIC, THE CARSON MOBILEHOME PARK RENTAL REVIEW BOARD MEETING DURING WHICH THIS HEARING WILL BE CONDUCTED WILL BE HELD VIRTUALLY (I.E., REMOTELY VIA AN ELECTRONIC TELECONFERENCING SOFTWARE APPLICATION, WITH NO COMMON PHYSICAL MEETING LOCATION). THE MEETING WILL BE BROADCAST LIVE ON TELEVISION AND ON THE CITY'S WEBSITE (SEE DETAILS BELOW), AND NO ONE WILL BE ALLOWED INTO THE CITY COUNCIL CHAMBERS FOR THE MEETING.**

2. The phone number that you will use to call into the meeting to provide your comment;
3. Name of your mobilehome park and your space number (if applicable); and
4. Topic of your comment.


If you provide the above information via email or phone to Ms. Matthews by **Tuesday, October 13, 2020 at 6:30 p.m.**, you will be notified via email or phone (based on whichever method you used to submit your request to provide public comment) on Wednesday, October 14, 2020 before noon with details about how to call into the meeting, including the phone number to call and the time when you should call.

The owner of Colony Cove Mobile Estates is requesting a temporary capital improvement rent increase of **\$8.19** (or 1.26% to 1.53%) for five (5) years, per space, per month for 407 of the 419 rental spaces in the mobilehome park. The capital improvement rent increase request is for expenses associated with street repairs; new carpet, fitness equipment, and cameras in the clubhouse; light fixtures throughout the park; repairs to the manager unit; sewer drain covers; pool repairs; and the City's application filing fee. The actual approved increase amount may be lower or higher depending on the Board-approved rent increase amount and term.

A copy of the application for the capital improvement rent increase request and its supporting documentation are available in electronic form and may be requested via email from Tara Matthews, Interim Housing Program Manager. The staff report with exhibits will be available in electronic format not later than the afternoon of Thursday, October 8, 2020 and may be requested from Ms. Matthews.

Please note that, in the event you challenge the approval or denial of the capital improvement rent increase request, your challenge may be limited to the issues raised at the public hearing or addressed in correspondence delivered to the Board prior to the public hearing.
